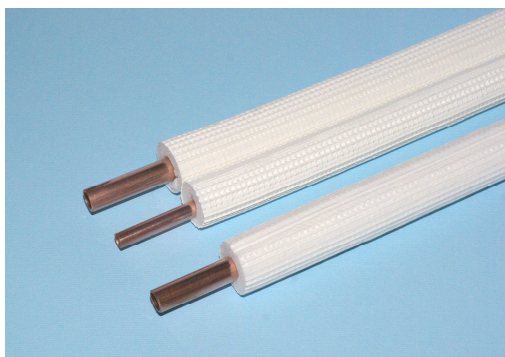




INSULATED COPPER PIPES SPLIT CLASS-1



Copper pipe specification:

Alloy: Copper Cu DHP 99,90 min.
Dimensions and tolerances: according to EN 12735-1
Total residual: < 0,38 mg/dm²
Inside surface smooth and bright.
Physical state: annealed (R220 according to EN12735-1)
Excellent resistance to corrosion.
Suitable for gas R407C, R410A e R32

Insulation specification:

Expanded foamed polyethylene (PE) with closed cells.
Colour: white
Insulation thickness: approx. 6 mm (for \varnothing 1/4" e 3/8") - 9 mm for all other \varnothing
Fire reaction according to EN 13501-1: self-extinguish CLASS 1
Odorless and non toxic – CFC free
Thermal conductivity: less then 0.040 W/mK at 40° C
Average density: approx. 30 kg/m³
Working temperature: -70° + 120°C
Maximum adherence to the pipe in order to guarantee maximum condensation prevention.
Marking on the insulation: "mts – FOMA Frosten*Split EN12735-1 - CL.1 – \varnothing x W.T. – GAS R407C
R410A – R32 – date"

Packaging

Coils 25 or 50 meters (20 m for the double) individually wrapped in film.

Each coil has an identification label with product name, dimensions and length.

Pipes with flattened ends.

In order to better insert the pipes in the canalization and make an easier bending Foma provides pipes of \varnothing 1/4" and 3/8" with 6 mm insulation. Anyway the above mentioned specifications remain guaranteed
